

# IHNSW SUSPENSION LIST Effective 23/5/2024

The new IIHF Rule Book has made comprehensive changes to penalties. IHNSW is working to implement these changes into our suspension list.

Suspensions are graded on 16-25 game season.

Proper Authorities are deemed IHNSW Executive Board.

The following additional rules apply in NSW: There is no appeal to 1 game suspension

### 1. Application and Scope

- 1.1 This document forms Schedule H of the IHA Competition Disciplinary, Tribunal & Suspension Regulations.
- 1.2 This document is aligned to the IIHF Official Rulebook 2023/24.
- 1.3 All Game Misconduct penalties assessed during a sanctioned IHA National League (AWIHL, AJIHL) or National Championship (Ginsberg, DeFris, Tange, Brown, Boxall) will be reviewed by a Match Review Committee. The Match Review Committee will review reports from the Game Official and audio-visual footage from an official broadcast or live stream (if available) and may use whatever processes deemed necessary or desirable to investigate the alleged breach. The Match Review Committee will render a determination as follows:
- 1.3.1 No further action required.
- 1.3.2 Player will be assessed the automatic suspension.
- 1.3.3 Player will be referred to a tribunal (Disciplinary Measures rule will be applied).

### 2. Suspensions

- 2.1 Suspension should be served in the competition equivalent (or higher) to the competition that gave reason for the suspension of the player concerned.
- 2.2 Subject to Clause 2.4, players who are eligible to play in a competition in another age category, should serve the suspension in the youngest category for which they are eligible, even if the suspension results from a violation in an older age category.
- 2.3 Graded and automatic suspensions listed in this document do not apply to international games operated under IHA jurisdiction. Disciplinary matters occurring during international games not operated under IIHF jurisdiction shall be dealt with by the respective Member National Association, except for exhibition games which occur within seven (7) days of an IIHF Championship. All disciplinary matters occurring during exhibition games within seven (7) days of an IIHF Championship shall be dealt with by the Directorate Chairman of the respective Championship on an expedited basis. The Directorate Chairman shall have the right to refer the matter to the respective Championship Disciplinary Panel for review and sanctioning. For all suspensions rendered due to incident in an exhibition game, the suspension shall be served during the remaining exhibition period and/or during the Championship immediately following the exhibition period.
- 2.4 The suspension will be considered fulfilled if the player does not play in the game(s) for which they had been disqualified regardless of whether the player was entered in the competition concerned.
- 2.5 Subject to Clause 2.4, suspensions for games beyond the competition in which the player is suspended should be imposed during a competition of the following season. The suspension will be considered served if the conditions under Clause 2.4 have been fulfilled and will expire at the end of that following season unless the respective team does not take part that season in an equivalent competition for which the suspension was assessed, in which case the suspension is carried forward for one (1) more year.

2.6 Any suspension applied due to a tribunal called for Supplementary Discipline, if upheld, will detail the total suspension applied to a player, and may, or may not, include graded and automatic suspensions listed within this document.

### 3. Graded Suspensions

"Competition" is based on the number of games played by the team and not the overall number of games in the competition.
